To promote the EV industry in India, Finance Minister Nirmala Sitharaman announced in the Budget 2022 speech that a battery-swapping policy will be introduced, and interoperability standards will be formulated to enable this policy. While BAAS is an attractive cost-effective alternative to setting up public charging infrastructure, this model could face hurdles in India.
